PARTICIPATION is SMART MARKETING

PROMOTION: The Chamber advertises the program on the Chamber website and in Chamber publications. Your business name is promoted on every certificate. The chamber web site's Business Directory also identifies your business as a program participant.

SIMPLE & COST-EFFECTIVE: Just mail the redeemed certificate to the Chamber. We reimburse you 95% of the face value within two (2) weeks. The Chamber keeps 5% to cover supplies, administrative costs and promotions.

HOW IT WORKS

- Gift Certificate is purchased at Chamber Office
- Recipient redeems gift certificate at participating Chamber member business
- Participating business signs Gift Certificate acknowledging redemption
- Participating business sends redeemed Gift Certificate(s) to the Chamber office (via mail or in person) and - within two (2) weeks of receipt - the Chamber issues a reimbursement check for ninety-five (95%) of the face value of each redeemed Gift Certificate.


FACTS about the GIFT CERTIFICATE PROGRAM

Gift Certificate Program Agreement

REQUIREMENTS FOR PARTICIPATION:

1. I agree to honor all Michigan City Area Chamber Gift Certificates presented for redemption at my business.
2. I understand that the entire amount of each Gift Certificate can be used to purchase non-gaming goods or services in one establishment only. Cash back and restrictions are at the discretion of the redeeming business.
3. As a participating business in the Gift Certificate Program, I understand my business will be listed alphabetically on all Michigan City Area Chamber Gift Certificates.
4. I agree to return to the Chamber office - either by mail or in person - all Gift Certificates redeemed at my business within ninety (90) days of redemption. Within two (2) weeks of receiving redeemed certificates, the Chamber will issue to my business a reimbursement check for ninety-five percent (95%) of the face value of each redeemed Gift Certificate.
5. Should I wish to discontinue my participation in the program, I agree to notify the Chamber in writing of my cancellation. I understand that my business will be required to honor any and all outstanding Gift Certificates that have been issued prior to the date cancellation notification is received by the Chamber. *(All Gift Certificates include an expiration date of twelve (12) months from the date of issue.)*
